

## **CROWDRISE'S "POINTS" SWEEPSTAKES**

### **OFFICIAL RULES**

Sweepstakes beginning and end date will vary depending on the sweepstakes and will be explained in the promotional materials advertising the Sweepstakes and these Official Rules.

1. **GENERAL:** Crowdrise's "POINTS" Sweepstakes are a variety of sweepstakes in which individuals can win certain prizes based upon their activities on the Crowdrise website, [www.crowdrise.com](http://www.crowdrise.com) (the "Site") related to earning Crowdrise Points.. The Official Rules apply to all Crowdrise "POINTS" Sweepstakes that include a link to these Official Rules in the promotional materials advertising the particular sweepstakes ("Promotional Materials"). An example of such promotional materials would be a post on Crowdrise's Facebook fan page or Twitter account as follows: "Next 6 people to get 10,000 Crowdrise Points at [www.crowdrise.com](http://www.crowdrise.com) get a Crowdrise tee." OR "Get 10,000 Crowdrise Points before Thursday and you'll be entered to win a Macbook Air" See Official Rules."

2. **HOW TO ENTER:** Go to the Site and follow the instructions in the Promotional Materials during the Sweepstakes Period and you will be automatically entered into the applicable Crowdrise "POINTS" Sweepstakes.

3. **SWEEPSTAKES PERIOD.** The Sweepstakes Period varies depending on the applicable Crowdrise "POINTS" Sweepstakes. Every Crowdrise POINTS Sweepstakes begins on the date and time (Eastern) that the Promotional Materials are made available on the Site or through a third party platform, such as Facebook, Twitter or other platform. The Sweepstakes Period ends when the applicable number of winners have been selected. For instance, for a Crowdrise POINTS Sweepstakes such as, "Next 6 people to get 10,000 Crowdrise Points at [www.crowdrise.com](http://www.crowdrise.com) get a Crowdrise tee," the Sweepstakes Period ends after the 6th person gets 10,000 Crowdrise Points.

4. **SELECTION OF WINNERS:** Winners will be determined from all eligible entries received based on the terms for each Crowdrise "POINTS" Sweepstakes set forth in the Promotional Materials and these Official Rules. The determination of the winners will be made by representatives of Sponsor whose decisions are final on all matters relating to this Sweepstakes. Winners will be notified by email at the email address provided upon entry within five (5) days after the date the winners are selected.

5. **PRIZES AND ODDS:** The prizes for each Crowdrise "POINTS" Sweepstakes will be described in the Promotional Materials. Odds of winning depend upon the number of eligible entries received and the number of potential winners set forth in the Promotional Materials. All prizes will be awarded (assuming sufficient number of eligible entries.) Limit: one prize per household, except as noted below concerning "Top Point Earner" Sweepstakes. Sponsor reserves right to substitute prizes of

equal or greater value. No other substitution or transfer of prizes permitted. Sponsor responsible only for prize delivery; not responsible for prize utility, quality or otherwise. Taxes and fees, if any, are the sole responsibility of winners.

6. **ELIGIBILITY:** The Crowdrise “POINTS” Sweepstakes are open to individual legal residents of the 50 United States and District of Columbia, age 18 or older as of applicable Crowdrise “POINTS” Sweepstakes start date set forth in the Promotional Materials, except employees (and their immediate families and members of the same household) of Sponsor and its affiliates, agents, judges and advertising and promotion agencies.

7. **TOP POINT EARNER SWEEPSTAKES:** Individuals who win any “Top Point Earner” Sweepstakes (e.g., Top Point Earner as of a particular date wins a prize) are not eligible to win any of the other Top Point Earner Sweepstakes at any time. For example, if you have the highest number of Crowdrise points as of a particular date and win a prize, you are not eligible to win any other Crowdrise Top Point Earner Sweepstakes at any time (e.g. Top 5 Point Earners Win a Prize; Top 10 Point Earners Win a Prize, etc.). Notwithstanding the above, individuals are eligible to win a Top Point Earner Sweepstake and also be eligible to win any Crowdrise Next Point Sweepstakes (e.g, Next 6 people to get 10,000 Crowdrise Points at [www.crowdrise.com](http://www.crowdrise.com) get a Crowdrise tee).

8. **VERIFICATION OF WINNERS AND DELIVERY OF PRIZES:** Winners may be required to sign an affidavit of eligibility and liability release and, where permitted, a publicity release. Prizes may be awarded to alternate winners if affidavits/releases are not returned within ten (10) days after mailing to winners or if prize notifications or prizes are returned as undeliverable. If prize is won by a minor, it may be awarded in the name of a parent or legal guardian in Sponsor’s sole discretion. Winners agree to use of name, address, likeness, and/or prize information for promotional purposes in any medium without additional compensation to the extent permitted by law, any such use with respect to minors to be subject to prior approval of parent or legal guardian.

9. **GENERAL:** The Crowdrise “POINTS” Sweepstakes are void outside the United States and where prohibited or restricted by law and subject to all applicable federal, state and local laws and regulations. The Crowdrise “POINTS” Sweepstakes will be governed by the internal laws of the State of Michigan. Any and all legal actions or claims arising in connection with the Crowdrise “POINTS” Sweepstakes must be brought in a court of competent jurisdiction within the United States of America. Sponsor and judges not responsible for late, lost, stolen, damaged, garbled, incomplete, misaddressed, postage due or misdirected entries, emails, mail or communications; for errors, omissions, interruptions, deletions, defects, or delays in operations or transmission of information, in each case whether arising by way of technical or other failures or malfunctions of computer hardware, software, communications devices; or for transmission lines or data corruption, theft, destruction, unauthorized access to or alteration of entry materials, loss or otherwise. Further, Sponsor and judges not responsible for electronic communications which are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's e-mail account to receive e-

mail messages. The use of automated software or computer programs to register or to enter the Crowdrise "POINTS" Sweepstakes is prohibited and any individual who uses or attempts to use such methods to register or to enter will be disqualified. Sponsor disclaims any liability for damage to any computer system resulting from participation in, or accessing or downloading information in connection with, the Crowdrise "POINTS" Sweepstakes and reserves the right, at its sole discretion, to modify, cancel, terminate or suspend the Crowdrise "POINTS" Sweepstakes should any virus, bug, technical failures, unauthorized human intervention or other causes beyond Sponsor's control corrupt or affect the administration, security, fairness, integrity or proper conduct of the Crowdrise "POINTS" Sweepstakes. In the event of any such cancellation, termination or suspension, a notice will be posted and a random drawing will be held from among all eligible, non-suspect entries received prior to such time. Sponsor reserves the right, at its sole discretion, to disqualify any entrant (and his/her Sweepstakes entry) from the Crowdrise "POINTS" Sweepstakes or any other promotion conducted now or in the future by Sponsor or any of its affiliates if he/she tampers with the entry process or if his/her fraud or misconduct affects the integrity of the Crowdrise "POINTS" Sweepstakes. Sponsor reserves the right to correct clerical or typographical errors in Promotional Materials. By participating in the Crowdrise "POINTS" Sweepstakes, each entrant accepts the conditions stated in these Official Rules, agrees to be bound by the decisions of the judges and warrants that he/she is eligible to participate in the Crowdrise "POINTS" Sweepstakes. By accepting prize, winner agrees to release Sponsor and its directors, employees, officers and agents, including without limitation, its advertising and promotion agencies, from any and all liability, loss or damages arising from or in connection with the awarding, receipt and/or use or misuse of prize or participation in any prize-related activity.

10. CAUTION. ANY ATTEMPT BY AN ENTRANT TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE CROWDRISE "POINTS" SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT PERMITTED BY LAW.

The winners list will be sent to requesting parties after selection and verification of winners. All requests to receive a copy of the winners list must be made within thirty (30) days of the end of the Sweepstakes Period.
