1. **HOW TO ENTER:** Go to www.Crowdrise.com (the “Website”) and sign-up for a Crowdrise charity account during the Sweepstakes Period and you will be automatically entered into the Drawing (defined below) for the Crowdrise Sweepstakes – Win a \$1000 to your Cause.
2. **SELECTION OF WINNERS:** Winners will be determined from all eligible entries received in one random drawing (a “Drawing”.) One Drawing will be held on October 7, 2010.
